Statement

- More systematic management of the impacts of their products and processes, of their transport and distribution operations, and of their supply chains

- By communicating sustainability aims to the workforce and local community

Sustainable Development?

The past 20 years have seen a growing realisation that the current model of development is not sustainable; society is living beyond its means.

From the loss of biodiversity with the felling of rainforests or over fishing to the negative effect of current consumption patterns are having a significant impact upon the environment and the climate. Modern ways of life are placing an increasing burden on the planet.

A widely-used and accepted international definition of sustainable development is:

‘Development which meets the needs of the present without compromising the ability of future generations to meet their own needs’

Unless effort is made to make real progress toward reconciling these contradictions the world shall face a future that is less certain and less secure. It is our firmly held belief that decisive moves must be made towards more sustainable development. Not just because it is ‘the right thing to do’, but also because it is in the organisations long-term best interests.
